2024 was a successful year, as you have heard from our chairman. Many thanks to everyone for their hard work that ensured the events took place and were successful. The accounts were independently audited at the end of June before being passed to myself. They were audited by Mr Bob Squirrel who kindly agreed to continue as our auditor. The full year accounts were audited at the end of 2024 by Mr Bob Squirrel. I am pleased to report that again he has confirmed that the WCC accounts for 2024 are an accurate and true record.
